From August 2010 to January 2013, he worked as an Attorney Adviser for the SSA reviewing Administrative Law Judge decisions for legal sufficiency and assisting in fraud investigations. In June 2013, he began working for Colorado DBS. At DBS, he has worked 3 years as a SOAR certified advocate, 2 years as the supervising trainer, 1 year as the supervisor for the Cooperative Agreement to Benefit Homeless Individuals (CABHI) grant, and 9 months as the Interim Operations Manager for Colorado DBS. Recently, Colorado DBS has merged its programs into Easterseals Colorado, and Byron works as the DBS Trainer, BHI Disability Advocate, and as the State SOAR Lead for Colorado. His diverse background will help you see how the SSA reviews an application, how to advocate for yourself or others, and how to avoid the common mistakes made by many claimants and advocates.
