Kish, Esq., Director of Disability Benefits Services, graduated Magna Cum Laude from Catholic University of America, Columbus School of Law and has over ten years of experience in the disability field at both the Social Security Administration (SSA) and as an attorney advocate at the initial level. His experience includes work as an Attorney Adviser for the SSA reviewing Administrative Law Judge decisions and assisting in fraud investigations. He currently works in the nonprofit field as an attorney advocate representing clients before the SSA where he's maintained an 87.5% approval rate and average decision time of 144 days over the last few years. Byron currently serves as the Director of Disability Benefits Services and Colorado SSI/SSDI Outreach, Access, & Recovery (SOAR) State Team Lead. In addition to representing clients, he trains and oversees SOAR advocates throughout Colorado, serves as a consulting expert to the national SOAR program and other organizations, and collaborates with the SSA and DDS to ensure a quality and efficient disability adjudication process. His diverse background will help you understand how the SSA reviews an application, how to advocate for others, and how to avoid the common mistakes made by many advocates and claimants.
