- Teaches the importance of the SSA 827 Authorization to Disclose Information to the SSA
- Teaches the importance of the SSA 1696 Appointment of Representative form

### **The Medical Eligibility Criteria**

- Teaches the medical criteria for determining disability
- Examines the SSA's definition of disability and the five-step determination process
- Emphasizes how to develop a stronger case to get approved quicker without an attorney

### **Transition from Childhood to Adult Disability**

- Compares childhood disability (SSI) with adult disability (SSI/SSDI)
- Explains the importance of disabled adult child (DAC) benefits
- Teaches how to plan for disability issues that arise with transition age youth/adults
- Discusses the important role of a caseworker or family member in an application

## Presenter

### ***Byron J. Kish, Esq., SOAR State Lead, Advocate, & Trainer***

Byron Kish is an attorney with over 7 years of experience in the disability field. From August 2010 to January 2013, he worked as an Attorney Adviser for the SSA reviewing Administrative Law Judge decisions and assisting in fraud investigations. In June 2013, he began working for Colorado DBS. At DBS, he worked 3 years as an SSI/SSDI, Outreach, Access, & Recovery (SOAR) certified advocate, 2 years as the supervising trainer, 1.5 years as the supervisor for the Cooperative Agreement to Benefit Homeless Individuals (CABHI) grant, and 9 months as the Interim Operations Manager. In 2017, DBS merged its program into Easterseals Colorado, where Byron currently works as a Trainer, Disability Advocate, and as the State Lead for SOAR in Colorado. As the SOAR State Lead, he trains and oversees the SOAR advocates throughout Colorado, serves as a consulting expert to the national SOAR program, and collaborates with the SSA and DDS to ensure a quality and efficient disability adjudication process. His diverse background will help you understand how the SSA reviews an application, how to advocate for others, and how to avoid the common mistakes made by many advocates and claimants.
