# **MASK POLICY UPDATES**

The Colorado Department of Public Health & Environment (CDPHE) has recently issued the 17th Revised Public Health Order (PHO) 20-38. Within this order, clarification and instructions for Day Program providers have been added related to masking. As a result, the Neurological Rehabiliation Adult Day Program will exclusively follow the instructions set forth in PHO 20-38, including any future revisions made by CDPHE.

### **NEW REQUIREMENTS FOR MASKING**

All masking requirements are tied to the Centers for Disease Control and Prevention's (CDC's) county-based COVID-19 Community Level tool.

- ALL service recipients, staff, and visitors are REQUIRED to wear masks when the community level is MEDIUM or HIGH.
- NO masking requirements when the county's community level is in LOW.
- ALL service recipients, staff, and visitors are REQUIRED to wear masks when a provider experiences an outbreak, regardless of the CDC community level.

The NRADP will continue to monitor the community levels and make changes to our individual program policy as we see fit.
