CONFERENCE DESCRIPTION

This a practical course designed for OTs, PTs, and SLPs seeking an understanding of how self-regulatory and sensory processing disorders interfere with motor planning and acquisition of functional skills necessary for participation in the environment. Course material will focus on integration of NDT and SI theory into assessment and treatment of sensory processing disorders as they relate to a variety of diagnostic categories. Treatment strategies, use of equipment and adjuncts will be demonstrated in lab practice and through case presentations.

- Understand the importance of self-regulation, arousal and its impact on executive function.
- Identify categories of sensory processing disorders.
- Understand the relationship between praxis, self-regulation and executive function.
- Identify modulation and discrimination disorders in a variety of children.
- Apply treatment principles of modulation and praxis during case presentations.
- Practice handling techniques and use of equipment during lab practice.
