Six-year-old Benjamin spent the year alternating between weekly tele-therapy and in-person visits to Easterseals where he worked on taking steps with a walker. This blended therapy model was key to his development during the pandemic. Tele-therapy helped him build skills at home, like getting in and out of bed himself. At the same time, visits to Easterseals provided hands-on physical therapy. The combination helped him learn to walk with the aid of a specialized gait-trainer.

Family support is as integral to our services as the therapies we provide. Our network of parent liaisons and social workers have always been at the ready to help navigate challenges and concerns, but the pandemic elevated families' need for support. We furthered our commitment to building healthy families by expanding our comprehensive mental health services.

We welcomed licensed clinical social worker, Brittany Wilkie, as Director of Social Services and bilingual psychologist, Citlaly Gonzalez. They add their respective expertise in trauma-informed care and autism to our already strong team of mental health clinicians.





An investment in specialized training enabled the first phase of Facilitating Attuned Interactions (FAN) Training.

This approach, in partnership with the Erikson Institute, is intended to build collaborative parent-provider relationships that lead to more effective therapy outcomes. The ability to read parents' cues and attune to their needs guides the therapist to the most appropriate and empathetic response.

Representatives from our occupational therapy and social work team participated in a monthly training program ahead of their own reflective supervision. They're helping to strengthen parent/child connections by offering new ways to communicate and interact - particularly in challenging situations. FAN training will extend to all our clinicians, parent liaisons and social workers in FY2022 to help keep

children and their families emotionally strong.

### **Centering Equity & Inclusion**

Our main goal is to ensure that all people, no matter what background or ability, are 100% included and 100% empowered.

Our advocacy extends to people affected by disabilities who also identify with other underrepresented groups and minorities.

Efforts to address systemic inequities in 2021 included:

#### The Pediatric Health Equity Initiative

Easterseals established the Pediatric Health Equity Initiative to help end racial disparities in healthcare. CDC research recognized a three year delay in the time it took to identify and support Black families' concerns about their child's development. They were less likely to be diagnosed at an early age, resulting in the need for longer and more intensive therapies. Easterseals DuPage & Fox Valley was one of three affiliates to receive a generous grant from Abbott Laboratories to help close this gap. This investment helped us reach more pediatricians, school districts and community organizations. In year one, we were successful in screening and/or evaluating 171 families and connecting them to appropriate services.

The Pediatric Health Equity Initiative, in partnership with the Abbott Fund, made it possible to address developmental concerns shared by David's caregivers and his pediatrician. Complications at birth contributed to sensory challenges, and at age three he was experiencing sleep interruptions and difficulty managing his emotions. A thorough evaluation identified the need for weekly occupational therapy. Soon after, David's ability to express his feelings had improved and his caregiver felt empowered to enact strategies at home.

#### A Voice for Women & Girls

Easterseals DuPage & Fox Valley President & CEO, Theresa Forthofer, is proud to serve on the Governor's Council for Women and Girls. She joins female leaders across the state who advise on policy issues impacting women and girls in Illinois, including those with disabilities. She was identified by the Health and Healthcare Committee of the Council as an "exemplary leader, representing the voices of under-resourced communities who deserve unrestricted access to healthcare." As a participant in the group's Health Equity Summit, she brought attention to healthcare barriers that disproportionately impact women and girls with disabilities. Her advocacy helps to support the Committee's vision of equitable healthcare and optimal health for every woman and girl in Illinois.

Many early childhood programs were disrupted by the pandemic. We responded quickly to ensure that children didn't go without developmental and social-emotional screenings. In addition to the online Ages & Stages Questionnaire, we were the only organization in DuPage County to offer live virtual assessments with a developmental therapist. These were utilized by parents, caregivers, and DCFS case managers to help track milestones, assess behavior challenges and identify potential delays.

Easterseals experts also hosted a webinar: Supporting Child Development in a Pandemic in partnership with University of Chicago developmental pediatrician, Dr. Peter J. Smith.

## **Support for Working Parents**

The Lily Garden provided safe and inclusive childcare to 50 infants, toddlers and preschoolers.





#### **Building for the Future**

The Covid-19 pandemic disrupted our services and threatened our financial security. Without our community's generous response, a PPP loan and CARES Act funding, the impact would have been insurmountable. Long-time donors and Easterseals parents, Jim and Jane Miller, pledged a \$1 million endowment gift to protect us from future crises.
