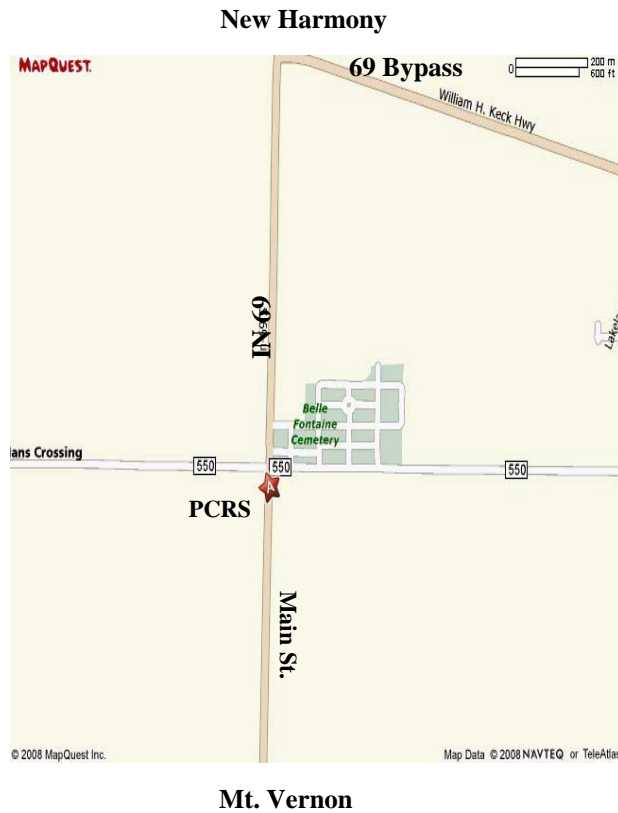

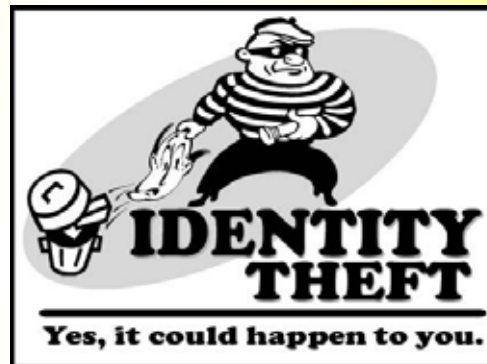
## AVOID IDENTITY THEFT

Clean out your offices at home or work. Gather up old files, receipts, cancelled checks, tax forms, etc. No need to remove paper clips, fasteners, staples, or binders. Our powerful shredders are equipped to destroy all those items with no difficulties.



## REASONS TO SHRED

- To protect you from identity theft and fraud
- To obey laws requiring shredding. "Any person who maintains or otherwise possesses consumer information for a business purpose" must properly destroy discarded consumer information according to the Fair and Accurate Credit Transition Act.
- To protect company and shareholders by safeguarding proprietary trade information
- When you partner with PCRS Supershred you help the environment plus save on waste disposal costs. All documents are destroyed and sent to a recycling center to be converted into usable products. According to the EPA-one ton of paper using recycled fiber saves: 17 trees, 3.3 cubic yards of landfill space, and 4077 Kilo-watt hours of energy.

- A Document of Destruction– a statement indicating that your documents were destroyed, the date of destruction, and the signature of the person supervising the destruction.
- Assurances of Confidentiality– a list of our Document Destruction Security Measures.
- Dependable Service and Flexible Options– Drop off boxes at our location or call for pick up.
- We can also provide you with lockable storage containers to securely store your documents until your next scheduled shred day.
