Call to Order

The Easterseals Charter School Board of Directors meeting was called to order by Board Chair, Ms. Lauren Burkhart at 1:02 PM, reminding everyone that the meeting is open to the public and being recorded.

Approval of July 21, 2020 Meeting Minutes

Ms. Burkhart asked all members to review and discuss the July 21, 2020 meeting minutes. With no discussion Ms. Burkhart asked for a motion to approve the meeting minutes.

Motion: Dr. Steve Sevigny made a motion to accept the July 21 2020 Charter School Board of Directors meeting minutes, Ms. Burt-DeVriese seconded the motion. Motion carried unanimously.

Review of August 31, 2020 Financial Statement

Ms. Chesley discussed the August 31, 2020 Financial Statement. She stated that the numbers are lower than budgeted due to the final count currently going on but year to date we are on track.

Ms. Burkhart recommended a motion to accept the August 31, 2020 Financial Statement.

Motion: A motion was made by Dr. Sevigny to accept the August 31, 2020 Financial Statement and, second Ms. Parsons-Kwiatek. Motion passed unanimously.

Principles Report

Ms. Hopkins presented the Principals report. She noted that the full day program started in Daytona Beach and was budgeted for 3 students, but now has 8 students enrolled. The total of students currently enrolled is 39 in Daytona Beach, 6 of those are online. 46 students in DeLand, 7 are online. We currently have one online teacher for both schools, who makes packets for parent pick up. January 22 is when Volusia online should end. We currently have 10 teachers, 9 are certified, which is something we have not had in previous years. We currently have a work group meeting once a month to redesign the library. The idea is to create an enrichment place or Exploration Place funded mostly by the Cook family. It is a work in progress, but we are looking forward to seeing the results in future months.
