Admission Requirements

Eligible participants must be 18 years of age and have a primary psychiatric disability with a history of hospitalization and/or outpatient treatment.

Individuals seeking residential services must have a need for assistance in the areas of self-maintenance, understanding mental and co-occurring illnesses, medication education, social functioning, and skill development.

Applicants must be able to comprehend and agree to a goal-oriented service plan and be able to participate in Easter Seals' activities and recommended treatment programs within their community.



24-Hour Residential Programs | MICA Residences | Gero-Psych Group Homes

Programs for individuals requiring 24-hour supervision in a highly structured environment that provide case management services including supportive counseling, education on the activities of daily living and self-medication management, peer group meetings, social and recreational activities, and transportation as needed.

MICA 24-hour residences for individuals who are dually diagnosed with both a mental health and substance abuse disorder are available only in Monmouth & Hunterdon counties.

Gero-Psych community living residence for individuals age 55+ is available only in Essex county.

Permanent/HUD Residences

Designed to assist homeless individuals with mental illness, case management and supportive supervision is provided along with assistance in activities of daily living and medication management.

Transitional Residences

Designed to facilitate continued growth towards independent living and a healthy lifestyle for individuals with mental illness who are capable of performing activities of daily living with minimal supervision.

Outreach Services

Case management is provided to individuals with mental illness living in their own homes or with family members to assist with the following:

- Mental and physical health barriers
- Activities of daily living
- Household management
- Obtaining and maintaining entitlements
- Linkages to recovery-learning community resources
- Building and maintaining social supports



Integrated Case Management Services (ICMS) Available in Hunterdon, Somerset & Warren Counties

Through clinical case management, the ICMS Program assists individuals with severe and persistent mental illness to integrate into the community of their choice whether they are living independently or in a residential group home.

Functioning as a liaison to state psychiatric hospitals, ICMS provides service coordination, advocacy, supportive and crisis counseling, location and maintenance of independent housing, assistance in obtaining entitlements, and activities of daily living.

PATH | Project for Assistance in Transition from Homelessness

Available in Hunterdon & Warren Counties

Provides outreach, case management, supportive counseling, and assistance with linkages to community housing resources to individuals identified as homeless or at risk of becoming homeless with a concurrent need for mental health services.

RHCF | Residential Health Care Facility *Available in Monmouth County*

For individuals being discharged from a state psychiatric hospital, RCHF provides 24-hour staff supervision, assistance with securing communitybased services, and developing skills necessary to achieve the most independent living possible.
