

# GIVING UP WAS NEVER AN OPTION!



In August 2009, Catherine welcomed her son Christian into the world. He was born prematurely, but succeeded with the help of Easter Seals RI Early Intervention services in reaching each milestone including making noises, head control and even rolling over.

Unfortunately, five days before Christmas, four-month-old Christian fell asleep on the couch with his caretaker, and suffered from a co-sleeping incident that left him clinging to life. Catherine found her son suffocated on the couch, gasping for air.

"His entire body felt lifeless," said Catherine.

Christian was rushed to a local children's hospital where he was put on life support. Once he was stabilized the doctors told Catherine that her son was most likely going to die, and if kept alive would probably never walk, talk, or know that she was his mother.

Miraculously, Christian started breathing on his own two weeks later, but there was still a tough road ahead. He suffered from a great deal of brain damage.

A month later, Catherine was able to bring her son home. However, before leaving the hospital, doctors suggested she seek services for Christian and recommended Easter Seals RI.

Once home, Easter Seals RI visited the family for an evaluation and suggested increasing the number of therapy visits Christian was receiving.

As time passed by, Catherine slowly started seeing her son progress. During each session Christian's physical therapist worked on stretches to manage his high muscle tone, as well as exercises to help strengthen and improve his head control. Over time Christian was introduced to speech, music and aquatic therapies.

Eventually, Christian graduated from Early Intervention and started receiving physical therapy services through the Easter Seals RI Outpatient Program.

Today, five-year-old Christian is showing great success! He can walk 20 steps in his walker, use an iPad with minimal help, and has relatively good hearing. Even though he still has many obstacles to overcome, such as cortical vision impairment, quadriplegic cerebral palsy, epilepsy, and a G-tube for food intake, he has a great attitude towards life.

"Christian is the bravest little man I know," said Catherine. "I don't know where we would be without Easter Seals. They gave me hope when I had none!"

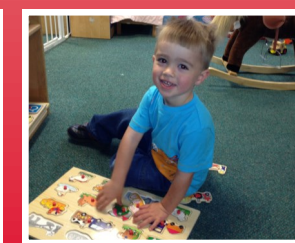
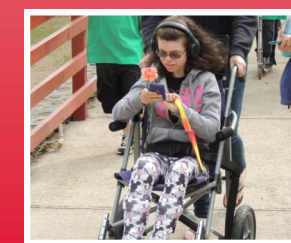
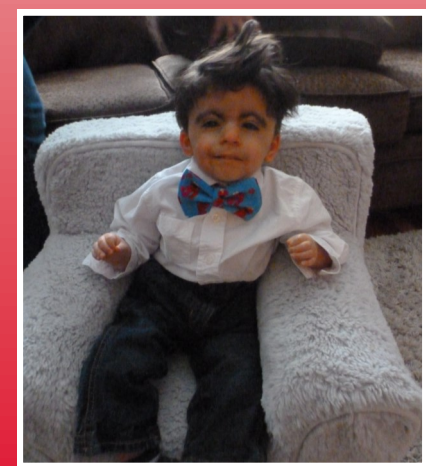

## RAISING AWARENESS & FUNDS TOGETHER

Our VIP (Very Important Partners) Campaign saw great success this year with the addition of two new teams: Ferry Orthodontics and T's Restaurants. Each team hosted their own events raising nearly \$30,000 combined. Ferry Orthodontics held the Ferry Orthodontic Scavenger Hunt throughout South County in 2013, and T's Restaurants held a hang-tag promotion during March. Each team, consisting of employees, family members, friends and patrons, reached deep into their community contacts to share the mission of Easter Seals RI and raise awareness of our programs and services.



## GENEROSITY MEETS COMMUNITY

Easter Seals RI received an outstanding amount of support from several foundations totaling more than \$43,000. Thanks to the generous contributions from the John E. Fogarty Foundation, Shriners Charities Trust, and the Rotary Club of Wakefield we were able to transform our Board Room into the new Visual Learners classroom. Through countless other gifts, we purchased a therapeutic equipment sanitation machine, and provided Outpatient therapies to small groups of families in the South Kingstown area.



## BUILDING A BRIGHTER FUTURE

Our Early Intervention and Outpatient services continued to grow over the past twelve months. We welcomed many new clients and their families into our programs, and expanded the services offered to our clients. We added a new Visual Learners group to our Early Intervention services that assists clients with developmental disorders, as well as those on the Autism Spectrum. The Outpatient program purchased an Interactive Metronome which has opened the door to a new world of opportunities for children and young adults who need assistance with attention, coordination, language processing, reading and math fluency, as well as control of impulsivity.
