We are delighted to announce the appointment of Maurice Woods, as President and CEO of Easterseals South Florida (ESSF). Beyond his experience across sectors, Maurice brings a passion for addressing equity and inclusion disparities for individuals and families with disadvantages or disabilities. Stemming from his lived experience as a black man from an underserved community with family members that have disabilities, Maurice is grateful that his new role will be leading an organization rooted in societal issues related to civil rights, the Americans with Disability Act, and the Affordable Care Act.

The COVID-19 pandemic provided many challenges for our program participants. The disruption of routines and structure proved to be a real struggle for children with intellectual and developmental disabilities. Job losses for adults with disabilities accelerated. For the elderly, increased exposure risks and availability of health care resources significantly impacted their ability to access adequate health care services. The team at ESSF responded with resilience, creativity, and compassion to meet the needs of the children, youth, caregivers and older adults we serve.

As we enter the post-pandemic phase, Maurice brings extensive experience with programs and service-related solutions and a leadership approach to impact opportunities which will take Easterseals South Florida to the next level.

Committed to a better "new normal" and to mutually beneficial partnerships, Maurice believes, "the ability to strategically collaborate and align our Easterseals South Florida mission with organizations across multiple community and business organizations are critical pieces of our impact strategy, and working in conjunction with our national organization, we are well-positioned to attract partners that align with our mission and are looking to alleviate suffering for those individuals and families hardest hit by the pandemic."

The Board of Directors has also hired our first Chief Administrative Officer, Barry Vogel.
