As we move forward, we are confident that with your continued support, we will continue to make a positive impact in the lives of all of those we serve. Thank you again for your unwavering support.



TOP FUNDING SOURCES





GUARDIANSHIP



608 clients served in 2021

MISSION:

Deliver comprehensive and expert guardianship services that support the needs and best interests of our clients. Our diverse team works together to advocate for and empower individuals in decisionmaking related to their health and well-being. We strive to enhance independence and involvement in life choices while also ensuring that personal desires, preferences, and beliefs are considered. Our goal is to address the needs of each person in a timely and least restrictive manner, while promoting individuality, independence, dignity, and self-worth.

Client Success Story:

One and a half years ago, Yessenia was residing with her aunt who was becoming increasingly frustrated with her constant behavioral issues and tendency to run away with men she met online. Yessenia's mother wanted to be involved but was unable to handle her daughter's behaviors and declined to take on the role of guardian. However, our team member Kellie stepped in and successfully convinced the family to allow Yessenia to move into her own apartment. Since then, Yessenia has been thriving and has not had any further incidents of running away. She receives support from independent living staff several times a week and recently started a new job.



SAFE BABIES HEALTHY FAMILIES



483 individuals served in 2021

MISSION:

Equip families to raise safe and healthy children is at the heart of our mission. By providing education, support, and resources, we aim to break negative cycles that can persist for generations. Through individualized case management in the home, our comprehensive approach includes education on prenatal care, childbirth and parenting. In addition, we offer some family socializations. This program provides support for the family until the child is kindergarten ready.

Amanda's Story:

Amanda had a difficult childhood marked by instability, drug use, sexual abuse, and the loss of her father. Pregnant at 18 and struggling with depression and anxiety, she was referred to the Safe Babies Healthy Families program where she met case manager Shaylen. Shaylen helped Amanda with resources, education, respite care, and therapy, and encouraged her to build a healthy support network. Amanda eventually obtained her high school diploma, got a job she loves, and is training to be a manager. With Shaylen's help, Amanda was able to bond with her son and create a positive future for him. They currently live with a host family and will be moving into their own apartment in March. Amanda values her relationship with Shaylen, who has been a consistent source of support and helped her build self-confidence and set realistic goals.

INDIVIDUAL PLACEMENT & SUPPORT



229 individuals served in 2021

MISSION:

Individual Placement and Support (IPS) is a model of supported employment for people with serious mental illness (e.g., schizophrenia spectrum disorder, bipolar, depression). IPS supported employment helps people living with behavioral health conditions work at regular jobs of their choosing. Although variations of supported employment exist, IPS refers to the evidence-based practice of supported employment. Mainstream education and technical training are included as ways to advance career paths.

106 consumers gained employment in 2021.

Client Success Story:

Jason was referred to the IPS program in 2020 when he was

homeless and seeking work but facing challenges with mental health, a criminal background, and unsuitable job placements. With support from his IPS Employment Specialist Linda, they worked on building his confidence, resume, and communication skills. They also addressed his background and explained the benefits of the Federal Bonding and DVR programs. After trying a job in a small factory, Jason decided to switch to cleaning and was eventually hired at a department store. He now enjoys his job and has moved into a one-bedroom apartment, gaining independence.



ADULT DAY SERVICES



140 individuals served in 2021

MISSION:

Empower disabled adults and enrich their lives by fostering a sense of purpose, self-worth, and community engagement. Through our adult day services, we aim to offer support to both the individuals and their families by creating a safe environment that encourages personal growth and independence. Our person-centered approach allows participants to choose their own activities and outings, utilizing their strengths and promoting self-sufficiency. By locating our centers in local communities, we provide opportunities for daily excursions and volunteer work, strengthening our participants' connections to the world around them.



ADULT RECREATION



110 participants in 2021

MISSION:

Provide a safe and inclusive environment where individuals can engage in recreational activities and foster a sense of community through learning new skills and hobbies, building relationships with others, and actively participating in the local community. Our goal is to promote relaxation, fun, and social connection while encouraging personal growth and well-being.
