•Adult Day Program: Engaging 130 adults with disabilities, fostering community living experience, and offering respite and support to caregivers.


•Recreation Programs: Touching the lives of 186 children, teens, and adults with disabilities, helping them build social skills, explore interests, and make lasting connections.



2022 FINANCIALS




EXPENSES BY CATEGORY

SAFE BABIES HEALTHY FAMILIES

Empowering pregnant women and families with children aged 0-5 facing risk factors in Milwaukee, Waukesha, Walworth, and Jefferson regions. Our mission involves comprehensive prenatal support, including childbirth education and parenting programs. Through personalized case management with tailored home visits, we guide families until their child is kindergarten ready. With a holistic approach, we empower at-risk families to build robust health, social, and financial networks.

The IPS Program is a specialized employment model tailored for individuals grappling with severe mental illnesses, including schizophrenia spectrum disorder, bipolar disorder, depression, and substance abuse issues. It aims to guide them toward mainstream job opportunities of their choice while addressing their unique challenges. Grounded in evidence-based practice, IPS emphasizes competitive employment, systematic job development, rapid job search, integrated services, benefits planning, zero exclusion, time-unlimited support, and worker preferences. By prioritizing individuals' preferences and capabilities while providing comprehensive support, IPS facilitates their integration into the workforce, enhancing their sense of independence, well-being, and overall quality of life.
