

Bright Stars, Easterseals DC MD VA's annual **night at the circus**, inspired children with disabilities and provided an inclusive experience for their families. The evening of fun and wonder **raised over \$370,000** to help keep Easterseals services affordable for the individuals and families we serve.

Child Development Centers



We acquired and set up our newest **Child Development Center in New Carrollton, Maryland**. Located near a Metro stop, this center offers convenient access and a high-quality early childhood development program for area families.



Sensitive to serving families regardless of their ability to pay, all our Child Development Centers participate in **voucher and scholarship programs**. This year the Falls Church center expanded this commitment by **accepting subsidies** from the Department of Social Services.



A Bethesda-Chevy Chase Rotary grant enabled classrooms in the Safeway, Inc. Child Development Center to install **Calm Down Corners** for preschoolers to reset themselves.



It sometimes got messy, but children at our Harry & Jeanette Weinberg Child Development Center, as well as other locations and Head Start centers, explored **STEM and STEAM concepts with hands-on activities**.



Families enrolled in the Jo Ann & Carl McNair Community Child Development Center had a blast at the **Spring Fling and fundraiser** organized by the Ashburn Assembly, International Order of the Rainbow for Girls.



All Child Development Centers renewed their annual **National Association for the Education of Young Children accreditation**, a nationally accepted standard of high quality. Additionally, the Silver Spring center received the **highest Maryland EXCELS rating** and the DC center received the **highest OSSE Capital Quality rating**.

children's programs

Head Start & Early Head Start



We opened our newest **Early Head Start center in DC**, providing early education for infants and toddlers, as well as support for pregnant mothers. With two Head Start centers in Southern Prince George's County, this third center marked Easterseals Head Start's first step to reach low-income families in the District of Columbia, beginning with Ward 5.



Head Start children took home their favorite stories from the **annual Book Fair**.



At our Head Start centers, Easterseals families can regularly pick up **healthful foods** donated by Capital Area Food Bank.



Families from our **Early Intervention, Respite, and Homeless Veterans Reintegration Program** had a memorable morning at the **White House sensory-friendly Easter Egg Roll**. This session allowed children with disabilities to experience activities in a relaxed, uncrowded environment.

Early Intervention



Early Intervention providers traveled to each child's natural learning environment to incorporate early intervention services into daily routines and achieve developmental outcomes.

Cook and His Family's Story



When Lorea and Kyle's son Cook was less than a month old, they received his diagnosis of a rare syndrome that causes him to stop breathing while he sleeps. As a result, Cook uses a ventilator that requires constant monitoring to ensure it continues breathing for him. While juggling demanding jobs, Lorea and Kyle could not find an inclusive daycare that could both accommodate Cook's complex medical needs and provide an enriching environment for their smart and social child.

That's when DC Child Care Connections directed the family to an Easterseals Child Development Center. Our center director and assistant director reassured the family that our staff would be able to provide the medical, social, and emotional support that Cook needed. Once the family enrolled, our staff underwent additional training to ensure Cook had everything he needed and Lorea and Kyle were comfortable.

Cook has made tremendous progress at our center and recently graduated from speech therapy. Lorea loves picking up Cook (and his now 4-month-old brother) as everyone stops them on their way out to say goodbye. On the impact Easterseals has had for Cook and his family, Kyle says, "Easterseals has allowed us to continue living our lives."

adult programs

Adult Day Services



Staff experienced a **Dementia Live virtual simulation** of what it's like to have dementia-related symptoms, such as cognitive and sensory impairment. Staff and community partners learned not only to appreciate these challenges more deeply, but also to be more compassionate providers for adults with disabilities.



In Hagerstown, we held a ribbon-cutting ceremony to celebrate the **grand reopening** of our modern and bright center. The building has beautiful outdoor spaces, ample parking, and serves 15 more participants than our previous location.



At the Morris & Gwendolyn Cafritz Adult Day Services center, Maryland Department of Disabilities Secretary Carol Beatty and Maryland Department of Aging Secretary Carmel Roques presented Easterseals DC MD VA with an **Americans with Disabilities Act anniversary proclamation**. The event concluded with neighboring Adult Day Services participants and other members of the Maryland Association of Adult Day Services joining an afternoon of party games and dancing.



Families in Silver Spring attended our **Community Fun Fair** to learn about Easterseals programs and local resources at the **Harry & Jeanette Weinberg Inter-Generational Center**. The community, along with Adult Day Services and Child Development Center participants, had fun with a petting zoo, activities, treats, and giveaways.



Field trips resumed to museums, libraries, restaurants, baseball games, and more.

Lauren's Story

Lauren is an independent 40-year-old woman who likes going to concerts and listening to her favorite music on her headphones. Living with cerebral palsy and type 2 diabetes, she uses a motorized wheelchair to get where she needs to go, including doctor's appointments and Easterseals Adult Day Services.

At Easterseals, Lauren works hard on her physical therapy and enjoys some quiet time in the company of staff and friends. Her physical therapist meets her two to four times a week at Easterseals for arm, hand, leg, and foot exercises. When hanging out around the center, staff are respectful of Lauren's needs, such as when she wants to spend time alone or with just a few friends.

Lauren's goal is to open a spa designed for individuals with disabilities. She envisions a space featuring a pool where people with various needs, including those with autism, can enjoy a family-friendly and relaxing environment. With her business partner, she is diligently working on securing funds to bring her vision into reality.

"I will always see Easterseals in my life," Lauren reflects. From now until she retires, Lauren knows she can rely on Easterseals for happiness, quiet, and independence. "Keep an eye out for the spa!" she adds.

veteran and military family programs

The Steven A. Cohen Military Family Clinic



Maryland Department of Veterans Affairs Secretary Anthony Woods (second from right) and Deputy Secretary Ross Cohen (far left) celebrated our **service to 3,500 clients** with high-quality, accessible behavioral healthcare since the Cohen Clinic opened in 2016.



Cohen Clinic psychologist Dr. Aaron Banas spoke about healing the hidden wounds of military service on a **"Welcome Home" podcast episode**.



For the **Cohen Clinic's Day of Service**, we joined with community partners to collect hygiene products to support veterans' overall health, in addition to mental health. Our team disbursed everything to the **Easterseals Homeless Veterans Reintegration Program** and local organizations serving veterans experiencing or at risk of homelessness.



Cohen Clinic Director Grace Caulfield addressed veterans' mental health in an **interview with WAMU 88.5** American University Radio.



Former member of the Maryland Veterans Commission Stan Seidel (second from right) presented the VSN with a **Veterans Day proclamation**, signed by Maryland Governor Wes Moore, as an outstanding veteran service organization.



We launched the free **My Career Toolkit app**, built by VSN career coaches, to prepare job seekers for a successful hire. Along with our online job hunt resources, job seekers everywhere could work independently on their search.



VSN career coaches provided one-on-one sessions with veterans, helping them secure fulfilling job placements in the civilian workforce.

Veteran Staffing Network



The VSN was selected as a **Hiring Our Heroes award finalist** for our work in veteran and military spouse employment support. Noting our veteran and military family services, Easterseals DC MD VA was a **Northern Virginia Chamber of Commerce Distinguished Service Awards finalist**.

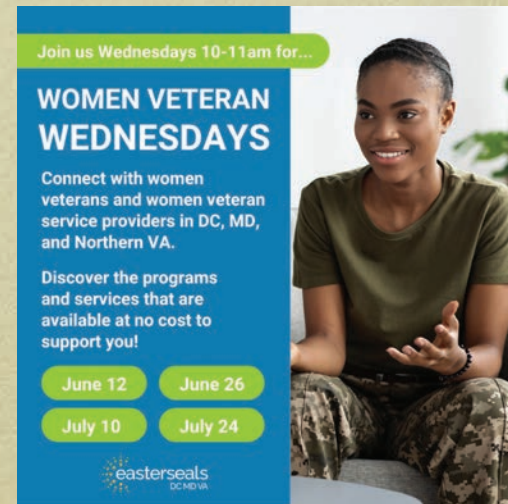

Homeless Veterans Reintegration Program



Old Laptops for Good Causes, Not Landfills donated **refurbished laptops** to HVRP veterans to facilitate online job training, career research, and job applications.



HVRP launched **Women Veteran Wednesdays**, a new series of virtual information sessions. Through this series, women veterans and women veteran service providers connected to discuss employment prep, in-demand training and certifications, job placement, and referrals for wraparound services.



Easterseals received a **statement of support from the National Guard and U.S. Army Reserve** as we continued to enhance quality of life and expand access to services for people with military backgrounds and their families.

Little Warriors Child Development Center



Lido Civic Club of Washington DC made a financial contribution toward **scholarships for Little Warriors**, children of wounded warriors, to attend an Easterseals Child Development Center.

Aretha's Story

Two years ago, Aretha was in a dark place. The 55-year-old divorced woman has three grown children and was honorably discharged from the Army in 1996, but medical challenges kept her from being able to work and Aretha fell behind in her rent. Despite receiving VA benefits, she was facing eviction.

Referred to Easterseals Homeless Veterans Reintegration Program, Aretha needed immediate help to stay in her home. She also recognized that she needed support in finding career training and helping manage her own mental health. "Being put in touch with Easterseals was a big turning point for me," she recalls.

Easterseals quickly became a partner in Aretha's journey, through its Veteran Staffing Network and Steven A. Cohen Military Family Clinic. Staff also connected her to other resources to help her find housing. With Easterseals' support, Aretha sharpened her interviewing and negotiating skills. Within weeks, Aretha had an offer as an Academic Support Teacher—she was even able to successfully negotiate for a higher salary than the initial offer!



respite programs

Robert S. Wilson Community Respite Program

For one session of our Saturday respite program, children enjoyed a day at a local arcade. The special activity also supported **ES Gaming's Global Accessibility Awareness Day**, which promotes accessible gaming. At the event, our **Respite children teamed up with Cohen Clinic military children** to celebrate Military Appreciation Month and Armed Forces Week.



Navy Exceptional Family Member Respite Care

We hand selected **highly qualified providers of in-home respite care** for active-duty Navy families with children with disabilities, in partnership with Child Care Aware® of America and the Navy Exceptional Family Member Respite Care.



Wellpoint Caregiver Resource Center

Easterseals DC MD VA Board member Dr. Darrell Gray II (third from right) unveiled the **Wellpoint Caregiver Resource Center** at the Harry & Jeanette Weinberg Inter-Generational Center in Silver Spring. This space is dedicated to supporting caregivers and connecting them with resources for a healthier quality of life.



Sarahi's Story

Imagine trying to manage your spouse's PTSD along with your own health issues. Or caring for five children, two of whom need special attention. Or being in college so that you can provide a better life for your kids. Each of these challenges alone is daunting. Now imagine you are dealing with all of them—at the same time.

That's the experience of Sarahi, who moved to the Washington, DC area with her husband and five children after his military service ended. But medical issues left him unable to work and left the family without an income.

When Sarahi found Easterseals, she was relieved to learn that her two youngest children, one of whom has autism, could enroll in an Easterseals Child Development Center as a Little Warrior—our scholarship program for the children of service members. That alleviated some of the family's financial strain. Sadly, other stresses remained.

Sarahi's husband started drinking and becoming physically abusive. Ultimately, the couple divorced and, as a result, their oldest daughter needed extra emotional support. Again, Easterseals was able to help through the Steven A. Cohen Military Family Clinic. Therapists there helped the daughter's recovery, as did participating in Easterseals weekend Respite program. In fact, all five children continue to enjoy the weekend program, a much-needed relief for Sarahi.

Easterseals Policy & Partnership Forum

For the second annual Easterseals forum on Capitol Hill, **Easterseals DC MD VA met with six Members of Congress from Northern Virginia and Maryland.** We discussed important policies about disability, veterans and military families, accessible air travel, childcare, pay equity, and more.



Dignitaries Learn About Easterseals

Throughout the year, **local legislators and military leaders toured Easterseals centers to learn about our services.** We shared insights about the needs of children, adults, veterans, and military families in our community. Their support helped us work toward finding solutions to improve the lives of those we serve.



An Inclusive Definition of 'Gold Star'

Easterseals DC MD VA cosigned a letter to Congress calling for a **standard definition of "Gold Star" to include all surviving families.** We were one of 50 military and veterans service organizations advocating for Gold Star families in the letter to Senators Reed, Wicker, Tester, and Moran, and Representatives Rogers, Smith, Bost, and Takano.

In Support of DC Pay Equity Fund

Easterseals testified before the DC Council in support of **restoring funds for the Early Childhood Educator Pay Equity Fund.** Initially cut from the mayor's proposed budget, the DC Council opted to include the Pay Equity Fund in the final budget.

Dignity of Air Travelers with Wheelchairs

In February, **we participated in a town hall with the White House and U.S. Department of Transportation** about a new rule protecting the rights of air travelers with disabilities. This rule became the Federal Aviation Administration Reauthorization Act of 2024, signed by President Biden in May.



Policy Initiatives in the 2024 Maryland General Assembly

In the 2024 session of the Maryland General Assembly, **we testified in support of the Caregiver Expense Grant Program and Behavioral Health Crisis Response Services legislation.** Both bills were passed and signed into law by Governor Wes Moore. We additionally supported the extension of the Therapeutic Child Care Grant Program, a bill that later failed in committee.

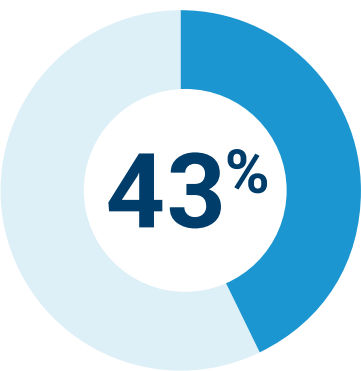

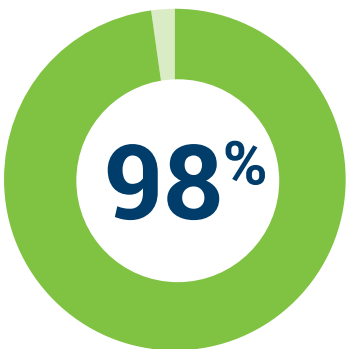

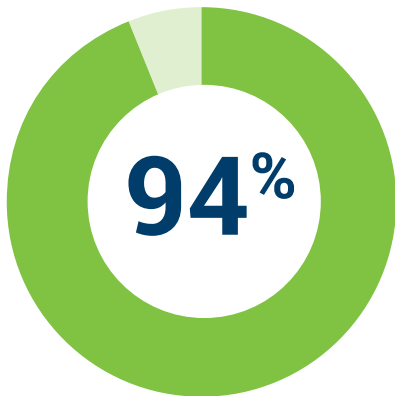

Your Dollars Make a Difference

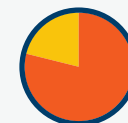
- \$100** covers 1 hour of early intervention therapy for a developmentally delayed child.
- \$500** provides 3 employment coaching sessions for a military veteran or spouse.
- \$1,000** allows 4 children—and their parents—to enjoy a day of fun and support at our Weekend Respite program.
- \$5,000** closes the gap between Medicaid coverage and the actual cost of 3 months of Adult Day Services care for 1 participant.
- \$15,000** covers the cost to provide 5 therapy sessions to 10 military veterans or their family members.
- \$25,000** allows 1 child to enroll in an Easterseals Child Development Center for a full year.

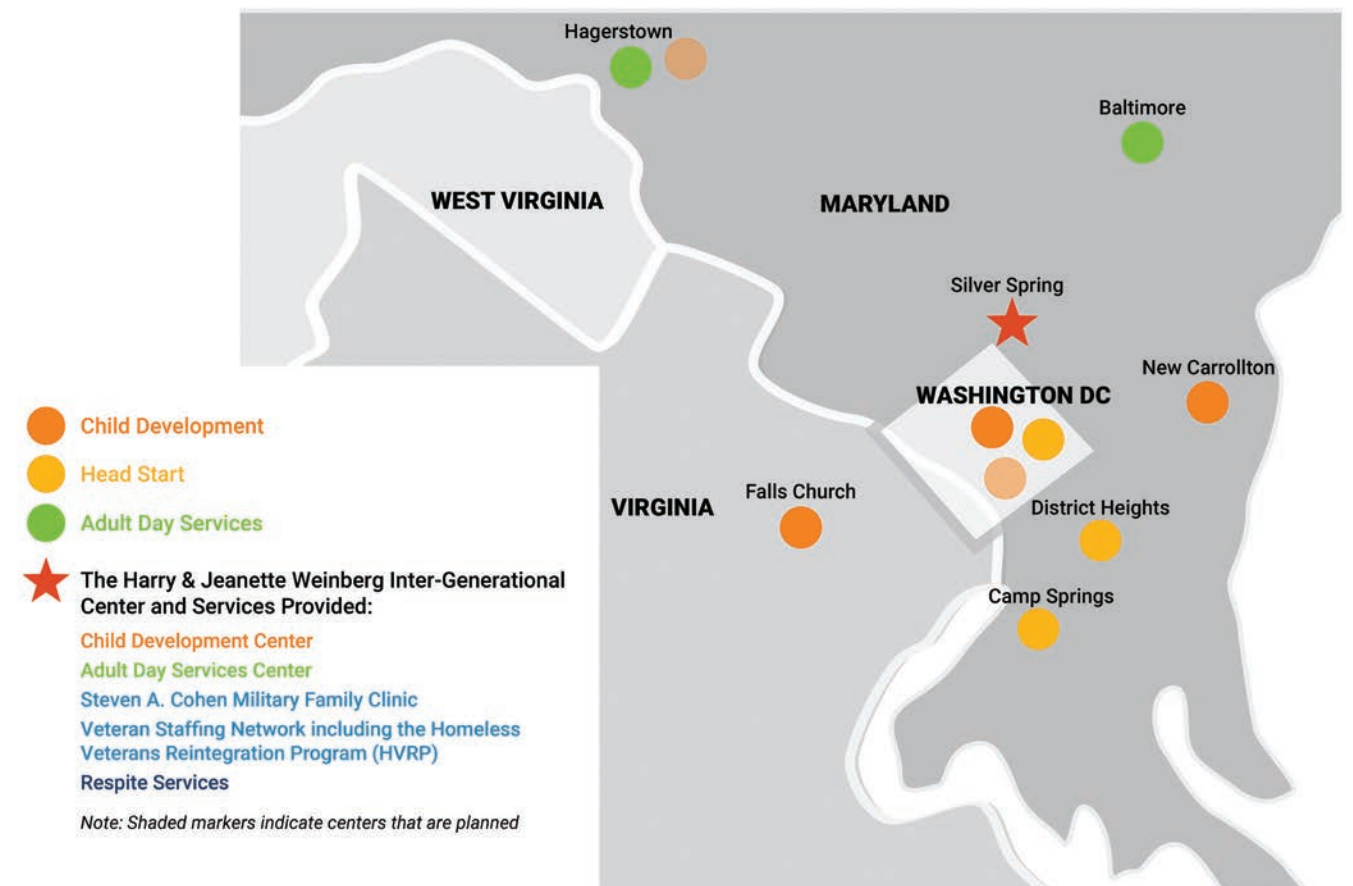
