



## Official Contest Rules

2019 Perfect \$10K Giveaway conducted by Easterseals DuPage and the Fox Valley Region, also known as Easterseals DuPage & Fox Valley

Maximum grand prize of \$10,000.00 USD.

Contest Rules and Regulations

### **RAFFLE TERMS:**

Easterseals DuPage & Fox Valley (ESDFV) has determined to support its charitable mission and activities by conducting a fundraising raffle based out of the Villa Park facility.

To that end, ESDFV will offer a cash prize of \$10,000.00 for purposes of raising charitable funds. This grand prize, as well as nine additional drawings for \$250.00 be raffled by chances sold for \$25.00 USD each. It is the charitable intent and purpose of this Raffle that the raffle's Net Proceeds (defined as gross revenue receipts minus Raffle related expenses) will be distributed for charitable purposes. All Net Proceeds will be used to support ESDFV programs.

The Raffle is known as the "Perfect Ten/\$10K Giveaway" and sales will be conducted between May 4, 2019 – August 16, 2019 by ESDFV in accordance with permits issued by the Village of Villa Park on May 1, 2019.

Kelly Moreland, Director of Development for Easterseals DuPage & Fox Valley, will function as the Raffle Manager and ESDFV will perform all marketing for the Perfect Ten Raffle.

For purposes of these Contest Rules, the following shall apply. Village of Villa Park, Village of Naperville and City of Elgin shall be referred to collectively as "Village." Easter Seals DuPage and the Fox Valley Region/Easterseals DuPage & Fox Valley shall be referred to as "ESDFV." Perfect Ten/\$10K Giveaway shall be referred to as "Raffle."

## ELIGIBILITY

The Raffle is open to persons at least 18 years of age or older at time of purchase or acquisition of the raffle entry. Raffle chances will be sold at 1 chance for \$25.00. Only one individual may be identified as the purchaser (or buyer) of the single Raffle entry. All federal, state and local laws and regulations apply. Raffle chances are void where prohibited by law.

The following persons are not eligible to win the Raffle: the Raffle Manager; President & CEO of Easterseals DFV, Chair of the Easterseals DFV Board of Directors and any immediate family members (spouses, and children) of the aforementioned.

## ENTRIES

Entries may be purchased via the Internet at [eastersealsdfvr.org/perfect10Kgiveaway](http://eastersealsdfvr.org/perfect10Kgiveaway) or [Perfect10KGiveaway.com](http://Perfect10KGiveaway.com), via US Mail at 830 S. Addison Ave., Villa Park, IL or in person at Easterseals DuPage & Fox Valley in Villa Park, Naperville or Elgin and at local events as announced. For Internet purchasers, the entries will be identical to all other entries entered. Each ticket or chance will have an equal chance of winning. Ticket confirmation number(s) will be e-mailed upon order completion. All e-mail communications, including the ticket confirmation, will be sent to the e-mail address provided during the purchase. It is the purchaser's responsibility to provide a valid, deliverable e-mail address in order to successfully receive the ticket confirmation. It is further the purchaser's responsibility to remove any spam or system blocks that would prevent the successful delivery of the confirmation e-mail. It is purchaser's responsibility to provide a valid, legible name, address, and phone number for any other purchases. For US Mail or drop-off purchasers, ticket confirmation number(s) may be mailed to any purchaser upon request within ten (10) business days of purchase. Physical raffle tickets will not be mailed. It is agreed that all sales of chances made by Internet, e-mail, in person, or through US mail are made final in the Village of Villa Park. The point of sale for all Raffle chances or tickets is at the ESDFV Center in Villa Park, IL.

Neither the Village, ESDFV, nor any of the aforementioned entities' agents, employees, board members, vendors, volunteers, or members assume any liability for lost, late, misdirected, mutilated, incomplete, illegible, undelivered entries or entries without proper payment received. Such entries shall be deemed invalid and shall be immediately disqualified.

## DRAWINGS

- **Grand Prize Drawing: \$10,000.00 USD** – The Grand Prize Drawing will take place on Saturday, August 17, 2019 at approximately 12:30PM at Lion's Park, 320 E. Wildwood Ave. Villa Park, IL. The winning chance for the Grand Prize Drawing will be determined by a helicopter ball drop. Each ball will be numbered with a corresponding entry/ticket number. A single winning entry will be determined by the ball that is closest to a pre-determined pin or target. If there are multiple balls that are equally close (as determined by a representative from Tighe, Kress & Orr P.C.), they will be concealed in a bag and one ball will be randomly selected. The identity of the holder of the winning chance or ticket will be notified by phone within 3 days. The second closest ball will be determined after the winning entry or chance is drawn. The second entry or chance will be determined for the purpose of selecting a back-up chance winner as is more fully set forth below.

Any and all purchases of raffle chances are final. There will be no refunds after the issuance of a raffle ticket or chance unless the Raffle is not conducted or otherwise cancelled as indicated by DuPage Code of Ordinances 28-22.

There is a minimum number of chances or tickets that must be sold before anyone is eligible for the \$10,000 Grand Prize. The minimum number of chances or tickets sold must be at least 1,500 before anyone is eligible to win the \$10,000 Grand Prize. If 1,000 – 1,499 chances or tickets are sold, then the Grand Prize will convert to \$5,000.00 USD. If 900 – 999 chances or tickets are sold, then the grand prize will convert to \$2,500.00 USD. If

less than 900 chances or tickets are sold, then the grand prize will convert to \$1,000.00 USD. All drawings are subject to the same rules and restrictions set forth herein.

## **ODDS**

Odds depend on the total number of tickets sold. The maximum number of tickets that will be sold is 3,000. If all tickets are sold, the odds will be 1 in 3,000.

## **GRAND PRIZE**

\$10,000.00 USD.

No other prize will be substituted for the Grand Prize, subject to the minimum number of chances or tickets sold, as described above. The prize must be claimed prior to the end of September 13, 2019 or the prize will be forfeited. Grand Prize Winner is responsible for all taxes associated with the winnings as noted below.

In the event that the Grand Prize Winner elects not to accept the Grand Prize or fails to accept it or if the prize is not claimed by the Grand Prize Winner by the end of the day on September 20, 2019 the winning entry shall be null and void. Advance notice will be provided to the winner via a certified letter. In that event, the Grand Prize will be awarded to the first back-up chance winner. The first back-up chance winner will be notified within 5 business days of the Grand Prize Winner's forfeiture in writing. The back-up chance winner will not be notified unless there is a Grand Prize Winner forfeiture. In the event of a Grand Prize Winner forfeiture, prize must be claimed prior to the end of October 18, 2019 or the prize will be forfeited. Back-up chance winner is responsible for all taxes associated with the winnings as noted below. In the event of a second forfeiture, the Grand Prize will be retained by ESDFV.

Grand Prize Winner (and in the event of a forfeiture, the back-up chance winner) is responsible for paying all taxes, fees, insurance costs, gratuities, and complying with all Federal, State, and/or Local laws with the acceptance of the Grand Prize.

- **Additional Drawings: 9 at \$250 each** - A drawing for a \$250.00 cash prize will take place on June 25, July 2, July 3, July 9, July 16, July 23, August 6, August 13, and August 15, 2019 at approximately 12:30 pm at the ESDFV Center in Villa Park, IL. Each winner will be selected separately from the Grand Prize Winner and will continue to be eligible for subsequent \$250 drawings running July 2 – August 15. The \$250 winners will be determined by a ticket drawn from a raffle drum.
- **Sales Incentive Drawing: \$1,000** – The Sales Incentive Drawing will take place on August 17, 2019 at approximately 12:30 pm at Lion's Park, 320 E. Wildwood Ave, Villa Park, IL. The winner of the Sales Incentive Drawing will be selected separately from the Grand Prize Winner. The specific rules and registration for the Sales Incentive Drawing are accessible on the ESDFV raffle website: [eastersealsdfvr.org/perfect10Kgiveaway](http://eastersealsdfvr.org/perfect10Kgiveaway). \$500 will be awarded to the individual who sold the grand prize winning ticket (if applicable) as determined by the seller's unique seller number. If the grand prize winner is also a ticket seller, they will receive the \$500 prize.

## **ALL PRIZES**

In the event of a winning entry having more than one name, the prize will be awarded to the first name listed on the entry. Neither the Village or ESDFV are responsible for resolving any disputes that may arise from the different individuals claiming ownership of a prize due to more than one name on an entry.

## **NOTIFICATION OF WINNER**

The winner will be notified by ESDFV by phone and certified letter with any requisite procedure to claim the prize. Winner is required to claim the prize by September 20, 2019.

Winner's name and location by city or town, and state, may be mailed to all entrants and may also be posted on-line. All contact attempts shall be made to the address, phone number, and/or e-mail address provided by the raffle entry purchaser. The winner, by entering, authorizes Village and ESDFV to publish their name and likeness.

## **TAXES AND IRS RULES**

The winner shall be responsible for any and all federal, state and local income or excise taxes, fees, assessments and like charges associated with the prize. A cash prize will be paid in gross and an IRS form 1099G will be issued to the winner, if applicable. The IRS has taken the position that amounts paid for chances to participate in raffles, lotteries or similar programs are not charitable contributions and, therefore, the price of the entry does not qualify as a deductible charitable contribution. Check with your qualified financial advisor for additional information.

## **CANCELLATION**

It is understood and agreed and a condition of chance purchase that ESDFV and Village have no responsibility to complete this Raffle if some unknown event prevents the Raffle. In that event, the Raffle may be cancelled without liability to ESDFV or the Village, and they shall only be responsible for return of chance purchase funds on hand and net of expenses including the costs of returning funds. In the event of inclement weather, ESDFV will make every attempt to reschedule the helicopter ball drop within one (1) week of the original drawing date. If that is not possible, the winner will instead be determined by drawing a ticket from a raffle drum.

## **WAIVER/LIMITATIONS OF LIABILITY**

Entry purchasers, by participating (and winner, by accepting the prize) release the Village, ESDFV and their respective partners, parent organization, vendors, agents, representatives, sponsors, service agencies and independent contractors, and each of their respective directors, officers, partners, elected officials, employees, and agents, including advertising and promotion agencies, from any and all liability with respect to participation in the promotion and possession or use of the prize(s) awarded and also acknowledge that they did not receive any representations, warranty or guarantee, express or implied, in fact or in law, relative to any prize, including but not limited to its quality, mechanical condition or fitness unless otherwise stated herein. A Raffle participant's sole and exclusive remedy for a claimed breach shall be limited to the return of the purchase price paid for his or her Raffle ticket or chance. In the case of any dispute, the decision of the ESDFV Raffle Manager shall be final.
