MISSION

Easterseals Oregon provides exceptional services to ensure that children and adults living with disabilities or special needs, and their families, have equal opportunities to live, learn, work and play in their communities.

OUR FOCUS IN OREGON

Easterseals Oregon is an indispensable resource for individuals with disabilities. The resources we provide help children, adults, seniors, veterans, and their families within Oregon Communities. We serve over 1800 individuals each year through high-quality programs such as workforce development for individuals with special needs and low income seniors, summer camp and recreational activities, respite care, and housing and employment for veterans and military families. We foster environments where every person is included and valued – with a positive impact on us all. We strive to ensure that everyone – regardless of their age and ability – is 100% included and 100% empowered.



PROGRAMS

Summer Camp & Respite: Easterseals Oregon's barrier-free summer camp for children and adults with disabilities and/or special needs provides a place where activities are designed to be inclusive. Campers discover new abilities, gain independence, make lifelong friendships, and build lasting memories. In addition, caregivers receive respite time to rejuvenate themselves. Campers get to stay four nights at Evans Creek Retreat during the month of July. Evans Creek Retreat is accredited by American Camp Association and located in Lyons, Oregon.

Connecting Communities Program: CCP provides services for individuals with disabilities who have language and/or literacy barriers. Participants receive services essential to their employment success. Our program offers workshops for job application completion, mock interviews, resume building, English classes, computer classes and help to find and retain employment.

****Homeless Veteran Reintegration Program:**

HVRP provides services that assist veterans who are homeless or at risk of becoming homeless. Our program helps them reintegrate into their communities and find meaningful employment. We provide veterans with the tools they need to gain new skill sets such as financial literacy, computer training, job search training, and interview guidance. Veterans learn skills to retain employment and become financially independent.

***Supportive Services for Veteran Families**

Program: SSVF provides support to veterans and their families to find permanent housing, prevent eviction, obtain documentation, secure benefits (SSI or VA), and increase skills and income. We provide case management to identify barriers and connect them with community resources such as immediate needs, employment, health care, legal aid, child care services, personal financial planning and transportation.

****Senior Community Service Employment**

Program: SCSEP is for low income seniors who seek employment, training assistance, and social engagement. Through our transitional employment program, we partner with community-based non-profit organizations and government agencies to provide participants with training opportunities to update their skills. During their part-time internship, seniors receive minimum wage to help supplement their income until they receive permanent employment. Our staff work with job seekers to target and achieve personal employment goals.
