

EMPLOYMENT & COMMUNITY SERVICES Embracing Change and Growth: A New Chapter for Easterseals of Greater Waterbury

In Fiscal Year 2023, one of the most exciting developments was the substantial growth of our Employment and Community Services (ECS) program at Easterseals of Greater Waterbury. At ECS, we provide both vocational, day and residential supports for adults with intellectual disabilities. This crucial division not only expanded its reach and served an unprecedented number of individuals but also saw significant growth in Individualized Home Supports (IHS) and Individualized Day Supports (IDS). These services are vital in ensuring full community participation and provide essential support to individuals, whether they live with their families or independently in their own homes. The success of this program has directly translated to enhanced quality of life, increased independence, and empowerment for our community members in greatest need.

Recognizing the increasing demand and our potential to magnify our impact, we initiated strategic planning to strengthen our infrastructure. After a comprehensive search, we pursued an exceptional opportunity to relocate the ECS programs to a more accessible facility on Watertown Avenue in Waterbury. This new building increases our visibility and accessibility, helping to better integrate our services within the community.

This modern space is not just an upgrade; it is a testament to our commitment to effectively meeting our participants' needs and to the dedication of our staff, who work tirelessly to improve lives daily. The improved layout enhances service delivery efficiency, while additional rooms allow us to offer more programs concurrently. Every design element has been carefully considered to ensure accessibility, comfort, and an environment conducive to growth and learning for our participants.

The relocation is scheduled for the end of the calendar year 2023, marking a transformative step for our organization. This move will enable us to serve more people, expand our program offerings, and deepen our community roots. As we enter Fiscal Year 2024, this new facility represents our commitment to innovation, broader community engagement, and a continued drive to change lives for the better. We extend our deepest gratitude to our donors, volunteers, and community members, whose unwavering support makes these advancements possible.

Easterseals Employment and Community Services (ECS) provides programming for adults with intellectual disabilities. We assist each individual achieve short and long term independent and vocational skills by participating in employment, pre-employment and/or day services, depending on the personal goals an individual is working toward.

AMY began attending Easterseals Day Support Option (DSO) program in April of 2022. Soon after joining, she expressed enthusiasm and the desire to have more responsibilities during day programming activities, such has helping to clean up and completing assigned tasks. Amy had observed individuals participating in the Group Supported Employment program at the ECS site in Danbury and expressed an interest in working with them.



She practiced skills, such as completing tasks independently, and in January of 2023, Amy began working three days a week with Group Supported Employment, assisting with cleaning contracts. Amy is a valuable team member and has continued to strengthen her skills. She is now working 5 days a week with her Group Supported Employment team.

Annual Golf Classic Held in Memory of Barry Lerman Raises over \$100,000 for Easterseals



On September 13, 2022, Easterseals Annual Golf Classic was held as a special tribute to Barry S. Lerman, a long-time, dedicated past board chairman for Easterseals of Greater Waterbury who passed away unexpectedly in February of 2022. Barry served on Easterseals board of directors for over 18 years. He

was a caring and generous person, who touched many lives, personally and professionally.

Barry grew up in Middlebury Connecticut. He was a successful business executive, co-founding his companies, Lerman Container and Custom Bottle in Naugatuck, Connecticut. Barry was a caring and generous person, who touched many lives, personally and professionally, and always found time to give back to his community. In addition to serving on Easterseals board of directors for over 18 years, he served on the board of directors for the Naugatuck Chamber of Commerce, making significant contributions during his professional career and in retirement, donating his time and talent to help others in countless ways.

Barry joined Easterseals board of directors in 1995, serving as Vice Chairman from 2006-2008 and Chairman from 2008-2013. He was an extremely active board member; highly invested in Easterseals employment program for adults with disabilities and served as an advisor for this program for many years. Barry was an avid golfer. He was a longtime member of the Country Club of Waterbury and, in retirement, enjoyed time at Pinehurst Country Club. He was an accomplished aviator and was nationally known and respected in the aircraft community. He gave back to others through his love of flying, often transporting medical patients and wounded warriors or their families.

Easterseals was honored to hold the 2022 Annual Easterseals Golf Classic in remembrance and celebration of Barry; a special friend, father, partner and all-around great guy.

The outpouring of support from sponsors, family and friends who joined us to honor Barry and support Easterseals was exceptional and helped Easterseals to raise over \$105,000 to help individuals and families in our community facing disability.

Dr. Christa Johnson joins Easterseals Center for Better Hearing

Easterseals Center for Better Hearing was pleased to welcome Christa Johnson, Au.D., CCC-A, to the audiology team in June of 2023. Christa received her Bachelor's Degree from California State University, Fresno and her Doctor of Audiology degree from the Rush University Medical Center in Chicago, IL. Dr. Johnson has over 10 years of clinical audiology experience and has spent the majority of her career in VA hospital settings. She currently practices in the Center for Better Hearing's Meriden and Waterbury locations.

Regaining independence through Easterseals Driver Assessment and Medical Rehab Program

Easterseals Driver Assessment program helps people to determine if they are able to safely operate a motor vehicle. Someone may need a driver assessment if they have a medical condition affecting their ability to drive, if they've lost the use of or have impaired sensation in a limb, if their doctor suggested they need a driver assessment or if they've been involved in a motor vehicle accident or experienced near misses.

Our primary goal is safety and helping each of the individuals that we serve to achieve maximum independence.

Recently, Jane went through Easterseals Driver Assessment program. She had sustained a stroke in November of 2021 and the effects of her stroke included experiencing deficits in attention, cognition, vision, and expressive language. She was seen for a comprehensive driver assessment over the summer and it was determined she was not yet ready to drive. Therefore, it was recommended that Jane see a skilled Occupational Therapist (OT) to address these deficits.

Lauren Pires, OT, Driver Rehabilitation Professional and Certified Driver Instructor, is the staff member who conducted Jane's driver assessment and saw her for therapy through our Medical Rehabilitation Program at Easterseals, located in the same building on State Street in Meriden. This made the process easy for Jane because her services were being provided in the same location and her therapist knew the areas that she needed to work on to operate a vehicle safely.



Jane was motivated and worked hard in her 11 occupational therapy sessions where she met her therapy goals and displayed improvements with all of her deficits and she returned to the Driver Assessment Program for a reassessment. Jane PASSED on February 1, 2023 and has been driving since then.

Jane was proud of her achievement after working hard to improve her skills and knowing with confidence that she now had the skills needed to drive safely. She was grateful for the ease she experienced being able to work with the same therapist who knew her deficits and helped to achieve her goal.

Jane expressed her gratitude to Easterseals for helping her to regain her independence. "I am so grateful for Easterseals. You've helped me to be able to do what I need to do!" Jane shared.


